**DESCRIPTION OF INTELLECTUAL GOODS PURCHASED**

Under which is known and understood as Intellectual property and follows the sole regulatory body of The International Guild of Danse De Rue Savate, INC. for the 12 month period which prepares me for the examination of the following \_\_\_\_\_Rank, and pertaining to that ranks curriculum.

\_\_\_\_\_The services that the seller is obligated to perform is the following: the teaching of the Martial Art of Savate Danse De Rue(sm) by an instructor or apprentice instructor to the buyer.

\_\_\_\_\_The Buyer fully understands that he has to go to the scheduled classes and perform his/her duty as a student of the martial art of Danse De Rue Savate(sm), and undergo an examination in front of the board of the International Guild of Danse De Rue Savate in order to pass or receive the rank that member has paid to learn as well as follow all the rules and regulations of the said corporation. The seller has no obligation to give the rank that the buyer has studied for if the buyer has not gone to class or has not pass the exam or simple warrants a rank. The buyer fully understands that the examination will be given during the Passage de Grade which is once per year during the last weekend of the month of July.

\_\_\_\_\_The buyer fully understands that the classes, courses, seminars, workshops and techniques are physical and contact is needed in order to learn properly the Martial Art of Savate Danse De Rue(sm). The buyer fully understands that accidents such as injuries to person or property as well as death may occur.

\_\_\_\_\_The buyer or the buyer’s family, kin, heirs, executors shall not hold liable any of the instructors, students, members of the said corporation, or associates is case of an accident to person or property that results in any type of injury or even death.

\_\_\_\_\_The buyer or the buyer's family, kin, heirs, release to said corporation its agents, and employees the right to take photographs, videotape, or digital recordings of me and the said corporation has all the rights to exhibit any photograph, print and electronic form publicly or privately and to market and sell copies. I waive any rights, claims, or interest I the buyer or my family, kin, heirs may have to control the use of my identity or likeness in whatever media used.

### **BUYER'S OBLIGATION**

\_\_\_\_\_The Buyer understands that the following equipment: Uniforms, Mouthpiece, Groin Protectors, Breast Protectors, Savate Gloves, Training Shoes, Training Knives, Training sticks have to be sanctioned by the International Guild of Danse De Rue Savate, INC or USA SAVATE.

## **SECTION FOUR.**

### **SECURITY**

I understand and agree that the services that I have purchased do not become fully mine to do with as I please, meaning stating to be affiliated with, use the name of the martial art of Savate Danse De Rue(sm) or make any claims to its knowledge until I have made all my annual membership payments and fully performed this agreement as well as passed all the board examinations of the International Guild of Danse De Rue Savate, Inc., for the specific Technical Rank that I have received tutelage.

Understanding that instructor statuses exist with in the said corporation and I have to learn the curriculum and pass all the board examinations of the International Guild of Danse De Rue Savate, Inc., for each and every specific Teaching Rank that I have received tutelage for. I understand that I have to be an active member of the Corporation, before I can teach the Art of Danse de Rue Savate(sm).

## **SECTION FIVE.**

### **PROMISES**

I make the following promises:

- A. The Intellectual property I have purchased has been purchased for me, and no one has any interest in the goods except you, the seller, who has retained any interest in them in order to make sure that I follow all the rules and regulations of the said corporation as well as pass all the examinations needed for each rank. Except for that interest, the goods are mine and will remain mine, and As long as I am an Active Member of the International Guild of Danse De Rue Savate, INC. no one else has any interest in them or claims to them.
- B. The Member understands that each Technical Rank Examination is given once per year and I have to acquire the necessary hours to learn the curriculum for each Rank. The Member further understands that if the examination (Passage De Grade) is missed for what ever excuse, that the Member will wait a full year to take the examination again.
- C. I promise not to teach any part of the curriculum of the International Guild of Danse De Rue Savate(sm); I have purchased a Service of instruction in any way, or to use or permit their use by anyone else in any manner that would lessen their value or cause the seller to worry about the goods considered Intellectual property. I promise not to use or teach anyone the instructions or techniques in any manner that is illegal or in violation of any policy or the rules and regulations of the said Corporation. If it should ever become necessary to teach, I will do so only after I have first contacted the International Guild of Danse De Rue Savate, INC., the said corporation and then only after I have passed the correct examinations and certifications of the abilities to instruct and under gone the apprentice needed for each teaching rank which are specified in the Code Book of this Corporation and am an active member.
- D. I promise to pay all membership fees to the International Guild of Danse De Rue Savate, INC. and any examination Fees, Seminar Fees or Apprentice instructorship programs if accepted and all other charges that may be made on the goods.
- E. If I am accepted to do an apprentice program I must make two Seminars per year including The Instructors Gathering as well as to attend the Annual Passage de Grade at the end of the July.
- F. I promise to cooperate fully with the seller in making this agreement work and, if requested, will cooperate in taking any steps or completing any papers that may become necessary or helpful to protect the interest that the seller has retained in these intellectual goods.

**SECTION SIX.**

**DEFAULT**

If any of the following events occur, I will be in default of my membership, when that happens, my main obligation as a member might be that I am placed on probation or disbarred from the Corporation. I must then, if requested, deliver the property serving as collateral to the seller, or should the seller so choose, the seller may come and revoke the ranks without notice to me and without the need for any legal papers. If the Sell must derive legal actions I will accept any reasonable expenses which may include any court costs and attorney fees the seller may have incurred. If the proceeds are not enough to fully cover all this, I agree to pay the seller the difference.

I shall be in default if any of the following events occur:
